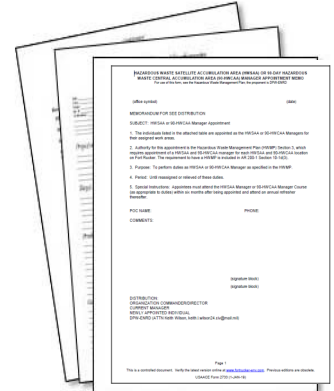

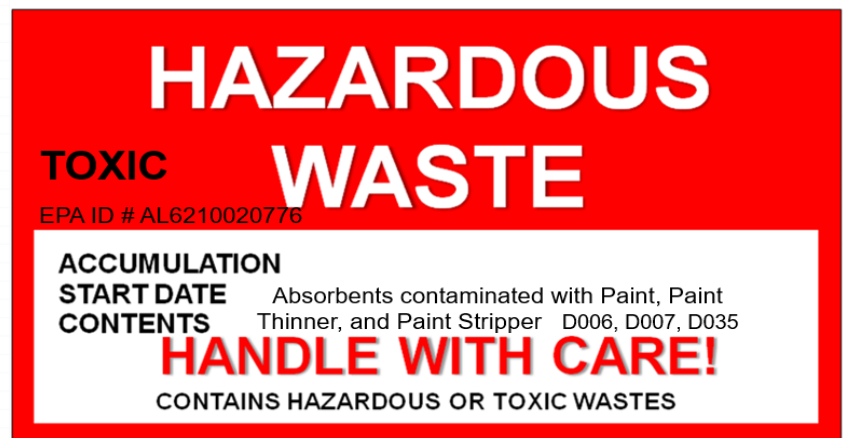
## January 2019 HWMP Update Summary

The following information summarizes the January 2019 changes that were incorporated into Fort Rucker's Hazardous Waste Management Plan. This plan is awaiting GC signature and will soon be posted on the Sustainable Fort Rucker website.

- ◆ Citations for hazardous waste regulations have been updated with the new citations from the Code of Federal Regulations (CFR) and the Alabama Department of Environmental Management (ADEM) Administrative Code.
- ◆ Hazardous Waste Satellite Accumulation Point (HWSAP) is now Hazardous Waste Satellite Accumulation Area (HWSAA).
- ◆ 90-day Hazardous Waste Accumulation Site (90-HWAS) is now 90-day Hazardous Waste Central Accumulation Area (90-HWCAA).
- ◆ Updated the locations of the 90-HWCAAs and interim 90-HWCAAs.
- ◆ Site Specific Spill Plans: Added the requirement that a Site Specific Spill Plan prepared for each HWSAA and 90-HWCAA must be submitted to DPW-ENRD annually by 1 Oct or when changes are made.
- ◆ Updated requirements for submitting written spill report utilizing USAACE Form 2718, Spill Notification Form – Must be submitted to DPW-ENRD within 24 hours of the incident.

### Additional requirements for labeling hazardous waste containers:

- ◆ Hazardous waste container labels and markings shall now include the Hazardous Waste Characteristics (such as ignitable, corrosive, reactive, and toxic) in addition to the words "HAZARDOUS WASTE".
- ◆ Reminder: Accumulation start date is recorded when containers reach a threshold of 55-gallons for non-acutely hazardous waste and one quart for acutely hazardous waste.



### Shortened time limits for 90-HWCAA:

- ◆ For Cairns, Shell, and Main Post 90-HWCAA, report containers in a 90-HWCAA over 40 days (instead of 60 days) to DPW-ENRD.
- ◆ For Hanchey, Lowe, and AMSS, transfer waste to the Main Post 90-HWCAA located at Building 1207 within 7 calendar days (instead of two weeks) of receipt.

### Updated signage requirement at 90-HWCAA:

- ◆ Signs will be posted at container accumulation areas that say: "HAZARDOUS WASTE – AUTHORIZED PERSONNEL ONLY" and "NO SMOKING."
